### Buoy Boys

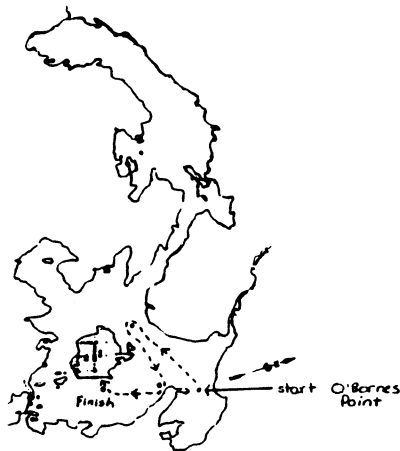

The Ministry of Natural Resources has cancelled the Gypsy Moth Spray program for this year. The M.N.R. heavily subsidizes these private-land sprayings. Effective May 17th, 1992, only table scrap garbage and recyclables will be accepted at the dump on Sheldrake Lake Road. Large items and brush must be hauled to the dump just north of Kaladar off of highway 41.

There are several bins at the dump to separate your recyclables - clear glass, coloured glass, tins, plastics, newspapers, corrugated cardboard etc.

## Announcement Board

The sign which the association purchased a few years ago and was located at the split at Sheldrake/Skootamatta Lake Roads was vandalized about a year ago. We received a cheque to cover damages and have decided that it is not feasible to replace the sign.

## Waterway Regulations

The Ministry of Natural Resources has published a provincial speed limit policy.

The Regulations have established a blanket shoreline speed limit for vessels of 10 km/hour, within 30 meters of any shore. This restriction does not apply in small rivers less than 100 meters wide, or canals or buoyed channels. Exceptions are also made for vessels towing a person on water skis, a surfboard, etc. when the vessel follows a trajectory that is perpendicular to the shore or where the operation takes place within an area designated by buoys.

## Ambulance and Fire Department Donations

Both the volunteer ambulance and fire fighters offer essential services to our community which could make a big difference in critical situations. It is important that we recognize these services and offer support. We would like to make a motion at the general meeting to make a \$250 cash donation to each of these services.

## Outdoor Equipment Drive at N.A.E.C.

North Addington Education Centre in Cloyne is asking for our help with their outdoor equipment drive. Greg Courtice, a teacher at the school is coordinating this project as a way to incorporate outdoor education into their curriculum.
